READ CAREFULLY BEFORE INSTALLING COVER

Robelle Industries Inc. (“Warrantor”) hereby warrants to the original purchaser that the safety swimming pool cover which is manufactured by Hinspergers Poly Industries, is free from defects in material and workmanship within the applicable warranty period provided that the pool cover is used in accordance with the Warrantor’s specifications. The warranty will begin on the date of purchase. If a defect in material or workmanship is discovered during the full year coverage period of the relevant warranty, the Warrantor will, at its discretion, repair or replace the pool cover. If the defect is discovered after the full year coverage period, the Warrantor will provide the purchaser with a discount off the current list price towards the purchase of a replacement pool cover. Labor costs arising out of a warranty including, but not limited to, removing or installing products or any other costs related with the warranty claim are not included and are at the purchaser’s sole expense.

EXCLUSIONS

THE FOLLOWING ACTIONS WILL VOID THIS LIMITED WARRANTY:

- Failure to maintain pool water at recommended levels as follows:
Mesh In-Ground Covers: 15"-18" below the top of the pool
Solid In-Ground Covers: 12"-16" below the top of the pool
On-Ground Mesh – 14" below top & On-Ground Solid: 12"-14"

This is especially important during the snow season as the extra weight may cause damage to the cover and hardware.

- If the cover is altered, modified, misused, or abused by any person.
- Damages caused by purchaser or any other third party.
- Damages caused by flood, tree limbs, hail, snow, ice, or any other acts of nature.
- If the pool cover is not installed strictly according to the Warrantor's original installation instructions and manuals.
- Utilization of the cover on a pool which is the incorrect size or shape for the cover (i.e., oversized rectangle on a freeform shaped pool).
- Damage to the cover because of burn holes from cigarettes, fireplaces or chemicals.
- Damage to the cover caused by animals (horses, deer, dogs, mice, etc.). Contact with sharp hooved animals.
- Utilization of the cover for the extended or continuous pool closure beyond the winter season (i.e., leaving the cover on the pool for periods greater than 8 months).
- Installation of the cover on a pool at a property that is abandoned or vacant, or without on-site supervision or security.
- Installation of the cover on a pool where more than 10% of the perimeter is installed with a raised wall treatment, lawn stakes, or any other installation of the cover which, in accordance with ASTM standards, results in the cover no longer constituting a safety cover.

CONDITIONS

ALL FREIGHT COSTS INCURRED SHIPPING THE POOL COVER BACK AND FORTH TO THE MANUFACTURING FACILITY IS THE RESPONSIBILITY OF THE ORIGINAL PURCHASER.

- This is a swimming pool cover for winter use only.
- The limited warranty provided herein covers the pool cover only; the limited warranty does not cover the pool deck, pool, pool mechanical systems or any other property of any kind whatsoever.

- The warranty is conditional upon the purchaser notifying the Warrantor of the defect as follows:

- a) A written claim is sent by mail to Warrantor at Robelle Industries Inc., 60 Campanelli Drive, Braintree, MA. 02184.
- b) The claim must be received before the lapse of the applicable warranty period.
- c) The written claim must include: the purchasers' full name and contact information, the date of purchase of the product, the dealer from whom the product was purchased, product serial number, item number and a description of the defect.
- d) At least three pictures of the defective product. One showing the entire cover installed on the pool and two others showing close-ups of the defect.

CARE OF THE COVER

- After removal, wash the cover thoroughly with tap water to remove debris or chemicals. Pool Chemicals can be extremely harmful to the cover if allowed to remain on the cover.
- Scrubbing is not necessary. Spray with moderate hose pressure on both sides and then dry completely before storage.
- The cover should be stored indoors, such as a basement, garage, shed etc., to protect it from the elements and animals.
- With hose pressure, wash each brass anchor to remove any grit or debris.
- Caution: Exposure to the outdoor elements reduces the strength of many components of the cover such as the fabric, thread, webbing etc. Each year added caution should be taken when cleaning and storing the cover. With each year it becomes more important to keep people and animals off the cover.

Robelle Industries Inc. sole liability under this Limited Pro-Rated Warranty is set forth above, and in no event shall Robelle Industries Inc. be liable for any special, incidental, indirect or consequential damages whatsoever, including but not limited to damages for personal injury, property damage, inconvenience, or loss of enjoyment.

This Limited Pro-Rated Warranty is granted subject to the laws of Massachusetts, and is to be interpreted, construed, and enforced pursuant to the substantive law of the state of Massachusetts, without regard to conflict of law principles.
